**PUBLIC NOTICE**

**List of Candidates Debarred from 85% Punjab State Quota Seats**

In continuation of the previous Public Notice dated **28.08.2026**, it is hereby informed that certain additional candidates have been found to have applied for admission against the **85% Punjab State Quota seats** and, simultaneously, to have applied for counselling/admission against the **State Quota seats of another State/Union Territory**.

As per **Clause 18 of the Government of Punjab Notification dated 10.07.2026**, candidates seeking admission against the Punjab State Quota are required to comply with the conditions prescribed therein. Upon verification, the candidates listed below have been found to be in violation of the aforesaid provision.

Accordingly, in accordance with the provisions of the aforesaid Notification, the following additional candidates are hereby **debarred from consideration for admission against the 85% Punjab State Quota seats** for the Academic Session **2026-27**:
