In continuation of the counselling process for admission to MBBS/BDS courses under NEET-UG 2026 and in accordance with the counselling schedule issued by the Medical Counselling Committee (MCC) for the States, the following **draft schedule for the Second Round of Online Counselling** is prepared for kind perusal and approval, please:

Note: Candidates who have applied under the Minority Quota shall report to the respective Minority Institution for verification of their eligibility for admission against Minority Quota seats on 07.09.2026.

Note: The candidates who have already applied under sports category but did not submit the hard copy, can submit the two sets of hard copy of online application form alongwith sports gradation certificate issued by the Sports Department and relevant proofs of sports achievements alongwith academic certificates on 07.09.2026 personally in the Admission Branch, BFUHS, Faridkot, **failing which their candidature will not be considered under Sports Category Merit.**

THE FOLLOWING CANDIDATES ARE ELIGIBLE FOR 2ND ROUND OF ALLOTMENT:

Candidates eligible for seat allotment in 2nd round would be from one of the following groups: -

Group-I: Registered candidates who did not get any seat allotment in the 1st round.

Group-II: Registered candidates who have secured seat & whose 1st round of allotted seat got cancelled during the document verification on reporting for admission will be considered for allotment of seat in the next round of seat allotment, with changed Category, subject to availability of seat in respective category.

Group–III: Candidates who have reported at allotted institute during 1st round of allotment and submitted willingness for second round up-gradation as **Yes**.

Group-IV: Candidates who have been allotted a seat during 1st round but Not Joined.

Group-V: Candidates who have resigned in online mode within the time frame from the allotted seat of first round at college.

THE FOLLOWING CANDIDATES ARE NOT ELIGIBLE FOR 2ND ROUND OF SEAT ALLOTMENT:

- (a) Candidate who has become ineligible due to having inadequate documents as per Eligibility Criteria as per Punjab Govt. notification/MCC- UG
- (b) Who have not registered in Round 1 or Round 2.

Note:

1. Candidate will submit willingness and security deposit as per the rules & regulations of Government of India posted on www.mcc.nic.in. Only those candidates will be considered for 2nd round who will submit willingness by depositing requisite security amount for participation.

The candidates to whom seats are allotted in the 1st round of counselling will also submit the willingness to participate in the 2nd round of online counselling, however, the security fee deposited by them will be adjusted and they will have to pay the remaining amount of tuition fee. Those who have already paid tuition fee more than Rs. 10,000 (5000/- of SC/BC) for Govt. colleges and Rs. 2,00,000/- for Private Universities/Colleges, need not to pay security deposit again.

Submission of consent/willingness is mandatory for participation in the 2nd Round of Online Counselling.

2. Candidate to whom seat will be allotted in 2nd round but they do not report/join at the college may exit with forfeiture (**i.e. The security deposit will not be refunded in such case**).
3. Candidates who will not join the allotted seat in Round 2 will be eligible for further rounds of counselling but the security amount deposited for 2nd Round will be forfeited and applicant will have to register fresh and will have to deposit the fresh security deposit for 3rd round alongwith. The provisions with regard to security deposit and eligibility for participation will be as per revised information bulletin posted on MCC website.
4. The security deposit will be refunded only in case no seat will be allotted in 2nd round of counselling.
5. Candidate will have to submit fresh choices/preferences for Round-2 online counselling. Choices submitted during Round-I will be treated as null and void.
6. Choices are locked automatically after last date and time for exercise choices. After last date and time for exercising of choices, it cannot be modified and any request to BFUHS regarding accepting/changing the choices will not be entertained.

FREQUENTLY ASKED QUESTIONS (FAQS).

- Q1: Is a candidate who did not report/join the allotted college during the 1st Round of Counselling eligible to participate in the 2nd Round of Counselling?
- Ans.: Yes. Candidates who did not report to or join the college allotted to them during the **1st Round of Counselling** shall be eligible to participate in the **2nd Round of Counselling**, subject to the applicable rules and regulations, **after depositing the requisite security amount.**
- Q2: After joining Second Round of Counseling, whether one can leave/ Resign the allotted seat?
- Ans: Once the applicant joins the 2nd round seat, he/she will be allowed to leave/resign the seat within the stipulated period but the security deposit will be forfeited.
- Q3: If a candidate does not report at the allotted college during Round 2 whether he/she has to register again for Round 3?
- Ans: Yes, Candidate security amount will be forfeited and he/she can participate in Round 3 only with Fresh registration and security deposit.
- Q4: Whether the candidate can upgrade the Round 2 allotted seat during Round 3?
- Ans: Yes, the candidate can upgrade the Round 2 allotted seat during Round 3 but once, the candidate will join the upgraded seat in Round 3, he/she cannot resign/leave the seat.
- Q5: If the candidate does not join the allotted/upgraded seat during Round 3, whether the security deposit will be forfeited?
- Ans: Yes, the security amount will be forfeited.
- Q6: When will conversion of seats to open merit will be carried out?
- Ans: The conversion of seats of NRI and any reserve category after exhausting all candidates in relevant category will be carried out during the Round 3. The said conversion will be done only when the eligible Candidates belonging to the said Conversion Category have exhausted.
